


Sustainable, resident-driven community development

TNP projects and programming possible through HUD Community Challenge Grant and partnership with TCLRC



IN LATE 2011, TNP AND the City of Warren were awarded a Community Challenge Grant through the US Department of Housing and Urban Development. This \$372,000 allocation funds planning and zoning strategies around neighborhood revitalization, with an emphasis on community outreach, citizen engagement, and inclusionary dialogue. This was the only Community Challenge Grant awarded in Ohio in 2011, and allowed for the addition of two key program staff at TNP in 2012: a Community Planning Coordinator and a Strategic Zoning and Planning Coordinator. The program will approach community development through basic parcel inventory, assessment, and recommendations for the repurposing of vacant structures and lots in the City of Warren.

IN 2012, TNP CONTINUED its collaboration with the Trumbull County Land Reutilization Corporation to work toward the shared goal of rejuvenating neighborhoods. This includes the return of vacant parcels and structures to productive use through property disposition and land re-use projects; preparation of a demolition strategy for Warren and Warren Township; processing of all resident requests for side-lots; and the co-creation and continued shared support of the Court-Ordered Community

Service Program (COCS). This partnership is integral across TNP's programming.

Working in conjunction with the Land Bank, TNP staff have processed 143 side lot requests in Warren in 2012, as well as assisted in the facilitation of 66 vacant lot and 19 vacant structure transfers.

Returning vacant land to productive use

TNP offers technical assistance, site management, education and community outreach for Warren Community Gardens







GARDEN RESOURCES OF WARREN (GROW)

TNP CONTINUES TO PURSUE EFFORTS to address the gap in the local food system, and to turn blight created by derelict vacant lots into opportunity for food production. Through GROW and a partner-ship with the Warren City Schools, TNP directly manages the Warren Community Gardens (WCG) sites at the former Roosevelt, Dickey, and Garfield elementary school sites as well as the Central City Unity Garden on a residential plot.

TNP offers tools and supplies, assistance with water infrastructure, technical assistance and community outreach to other existing and emerging gardens throughout Warren.

TNP continues to pursue efforts to address the gap in the local food system through the GROW program

GROW IS AN URBAN AGRICULTURE PROGRAM developed by Warren residents to transform vacant lots into community gardens and to offer education and support for urban agriculture. GROW sites build community, reduce food insecurity and provide a local, accessible resource for healthy foods. The goal of this program is to assist community in the creation and maintenance of local and accessible sources of fresh food as a means to positively impact the health of Warren neighborhoods, and to offer education and outreach around local food issues and support practices that are environmentally and economically sustainable.

GROW currently offers direct support to four sites plus the addition of three more for 2013, and offers additional technical assistance and support to several other autonomous sites. Through GROW, TNP also acts as a Warren distribution site for the Grow Youngstown CSA and will partner with the Lake To River Cooperative to bring a farmers market to Courthouse Square in 2013.


gregg's gardens

TNP offers support and assistance to gregg's gardens, a vacant land reclamation project that utilizes native plants. gregg's gardens reclaimed more than 25 vacant lots in 2012 through wildflower seeding, relying almost entirely on grass roots fundraising of over \$20,000. TNP supports gregg's gardens goals of adding an additional 100 lots through both direct installation, and partnership with the city on altering post-demolition specs to include native plant seeds instead of conventional grass seed. TNP and gregg's gardens will also continue to pursue the im-

TNP responds to complaints from residents and city officials

The goal is to secure vacant properties and parcels through clean-up and board-up efforts

IN JUNE OF 2012 TRUMBULL Neighborhood Partnership (TNP) established a Court-Ordered Community Service Program in partnership with Warren Municipal Court Judges Thomas P. Gysegem and Terry F. Ivanchak and the Trumbull County Land Reutilization Corporation (Trumbull County Land Bank). The program represents an accountable client placement agency for court ordered community service, wherein individual clients can, if so ordered by the courts, fulfill community service obligations as a sentencing alternative, term of judicial probation, or in lieu of fines. The program also serves as a cost-effective way to address community needs with an emphasis on the securing and maintenance of vacant properties.

Clients are assigned to TNP and perform their community service hours and work under the direct supervision of TNP staff. Activities include boarding vacant houses, litter collections and neighborhood clean-ups, work in community gardens, graffiti removal and other service activities that improve the quality of life throughout Warren neighborhoods.

The benefit of this program is twofold: it lessens the burden on the judicial system in housing low level offenders and processing warrants around unpaid fines, and converts those obligations into tangible, substantive labor for the benefit of the community at large. It is operated in partnership with the criminal justice system and local government, and seeks to promote sensible case-by-case solutions to issues faced by both the courts and the community.
