Background

Trumbull Neighborhood Partnership (TNP) is a community development organization located in Warren, Ohio that seeks to engage and empower residents and stakeholders in efforts to revitalize neighborhoods of Warren and its surrounding communities through initiatives that address and improve the quality of life. TNP's Garden Resources of Warren (GROW) Program is a multi-faceted vacant land reuse program that seeks to mitigate the impact of food deserts and the development of a robust and sustainable local food system in Warren through the support of community gardens and other community greening projects that encourage the use of native species and raised garden spaces as well as developing programs and projects that promote healthy behaviors such eating a healthier diet and living an active lifestyle.

The Healthy Community Partnership is a multi-sector collaboration working to create a healthier Mahoning Valley. Our goal is a community where residents live long, healthy and productive lives. To achieve this goal, we are catalyzing a community-wide movement to create equitable opportunities for health as well as encourage and support residents to make healthier choices.
